- Probationary Full Licence Membership is offered to asbestos licence holders in their first year of business and/or their first year of licensing

Maintenance Licence Holder

For companies who have held an asbestos maintenance licence for more than a year.

Requirements:

- Letterhead with company registration number and address
- Current asbestos removal licence
- Standard Operating Procedures

Membership categories

Associate Membership

Associate Members do NOT need to hold an asbestos licence. Associate Members typically offer services such as analysis, project/risk management, supplies/equipment or consultancy. This type of membership is for UKAS accredited laboratories, suppliers, consultants, recruitment services and distributors to the industry.

- Signed Health and Safety Statement
- Example training records for asbestos personnel (where applicable)
- CVs for Senior Directors (where applicable)
- Probationary Associate Membership is offered to a companies in their first year of business.

Information Membership

For anyone who requires an information service. This level of membership provides a cost effective way of keeping up with legislative changes and current working practices.

Requirements:

- Signed Health and Safety Policy Statement

Public sector/Not for profit Membership

For local authorities and not for profit organisations who require an information service only. It is also of benefit to local authorities who have a duty to manage asbestos but do not carry out asbestos works themselves.
